Compared to last August, the total number of homes more than \$750,000 available this month was lower by 17.0% and lower by 28.2% compared to August 2018.

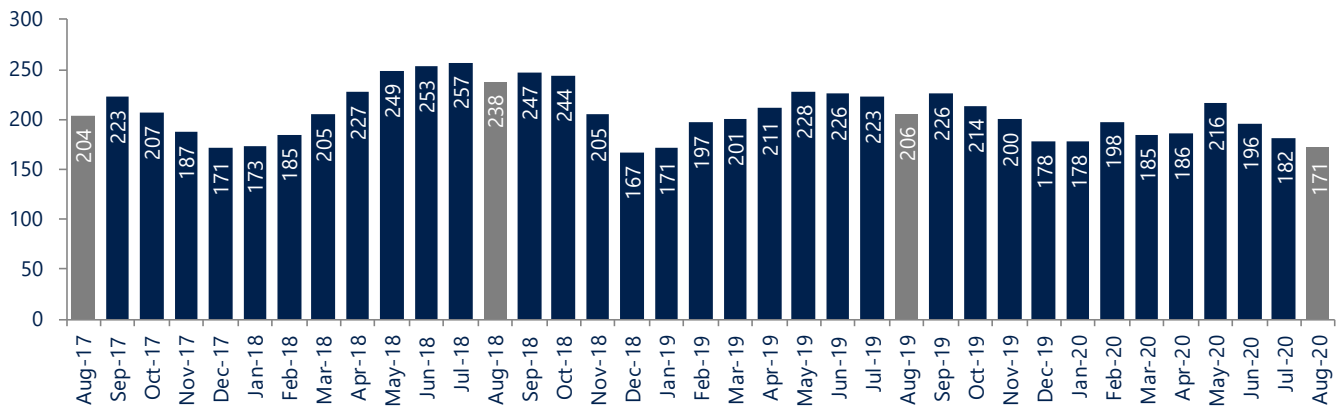
Active inventory this August was 6.0% lower than the previous month's supply of available inventory.

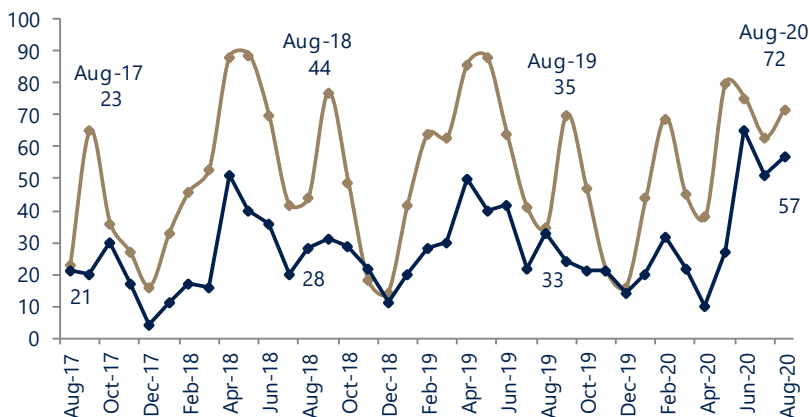

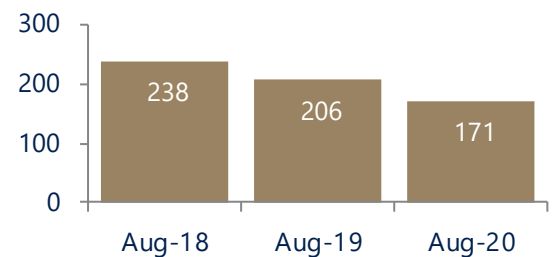

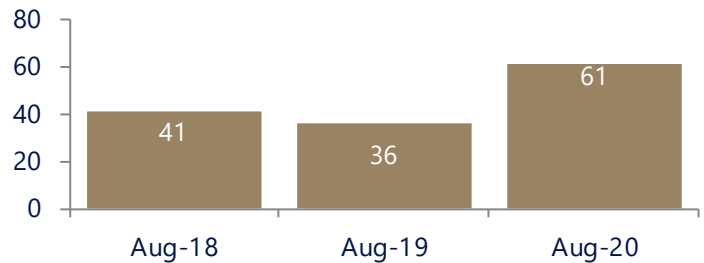


## Delaware County, Pennsylvania - August 2020

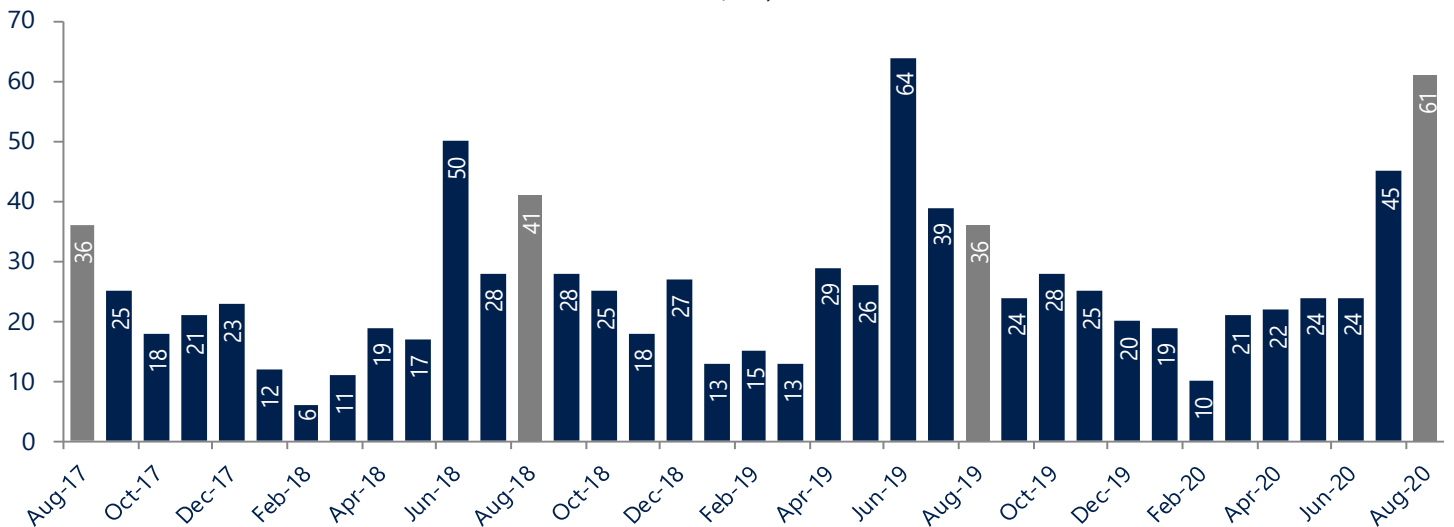
This month's units sold for homes more than \$750,000 was higher than at this time last year, an increase of 69.4% versus last August and an increase of 48.8% versus August of 2018.

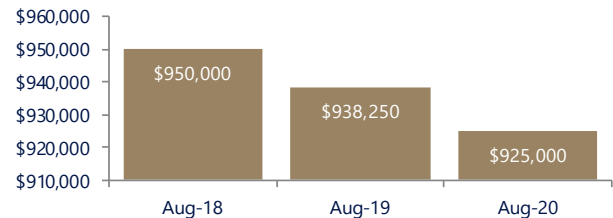
## Delaware County, Pennsylvania - August 2020

The current median sales price was lower by 5.6% than in July.

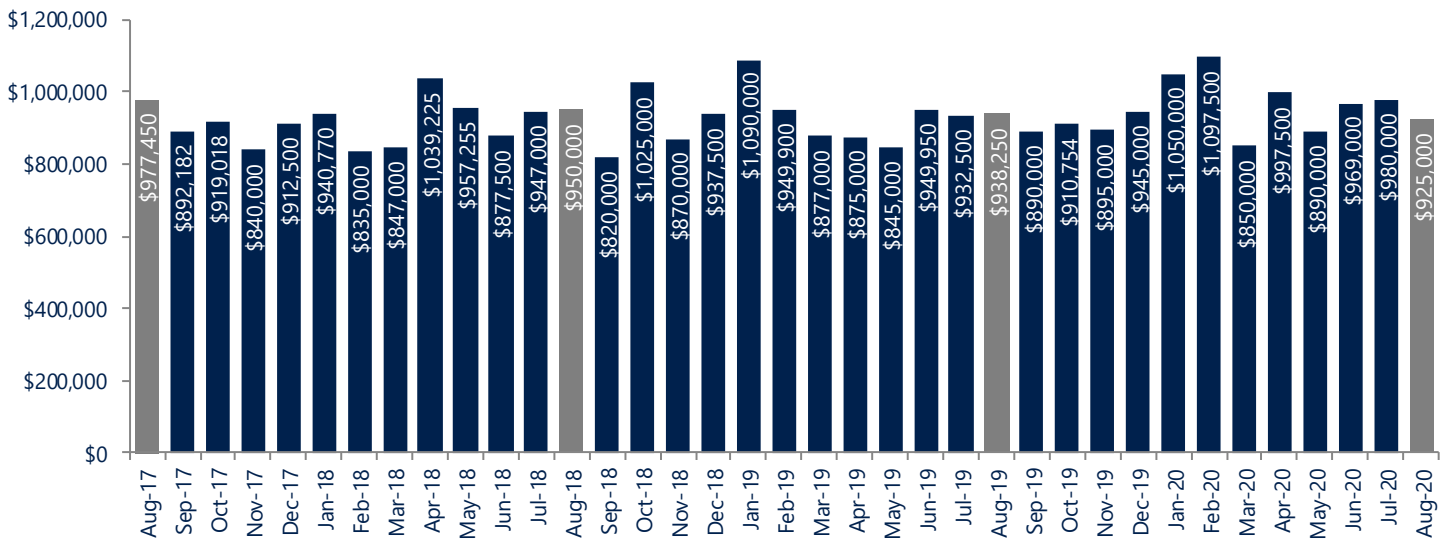
### MEDIAN SALES PRICE

Homes \$750,000+



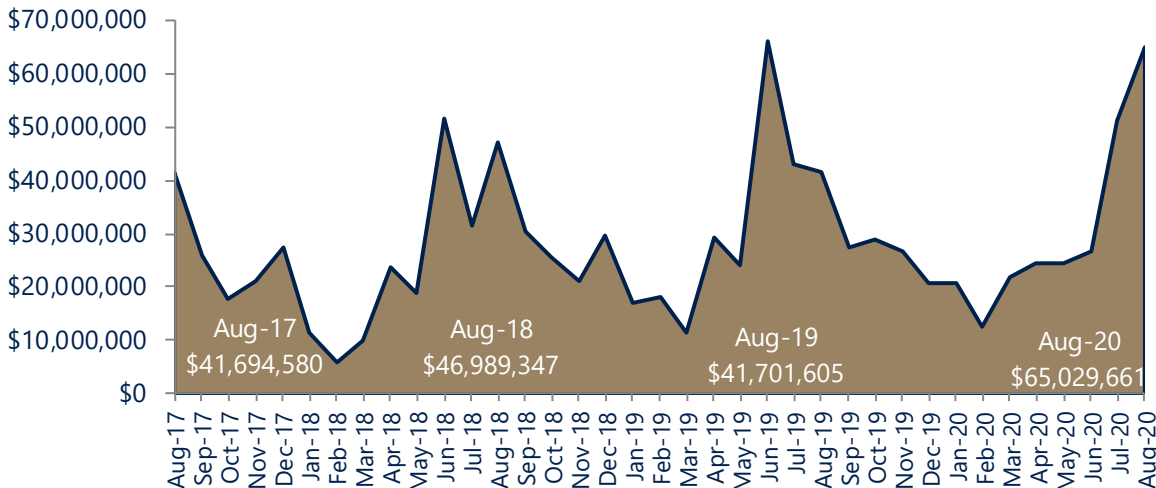
### MEDIAN SALES PRICE

Homes \$750,000+



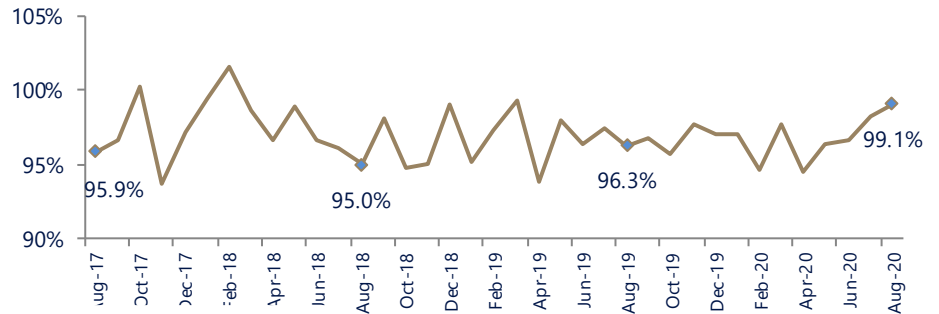
Total volume sold this August was 55.9% higher than the same month one year ago.

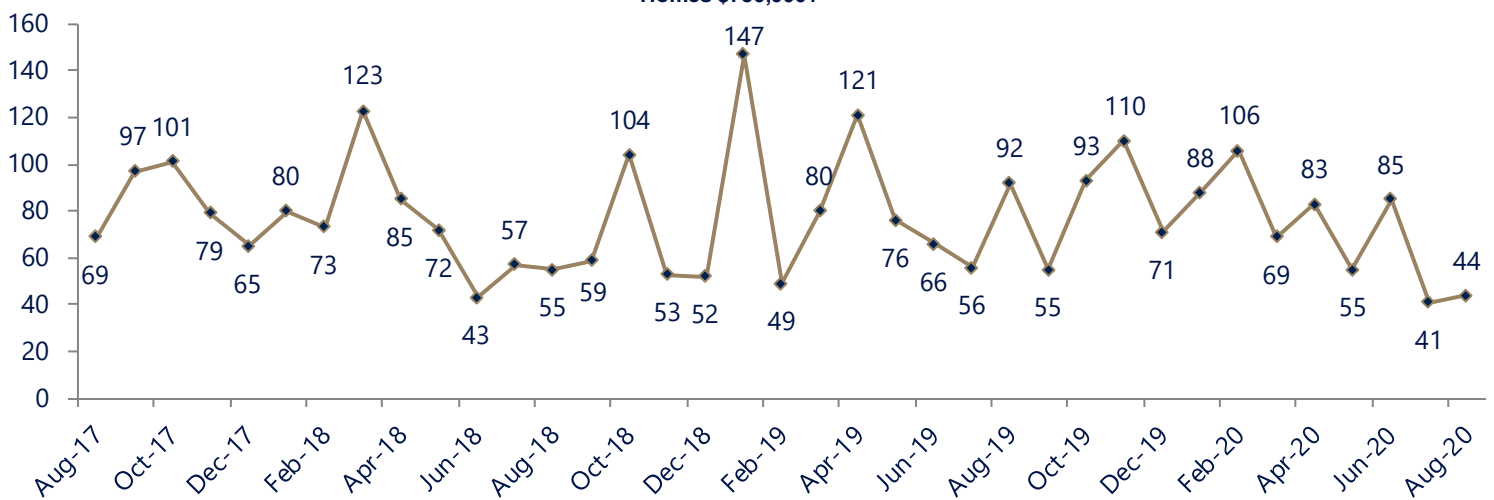
In August, the average sale price for homes more than \$750,000 was 99.1% of the average list price, which is 2.8% higher than at this time last year.

### SALE PRICE AS % OF LIST PRICE Homes \$750,000+

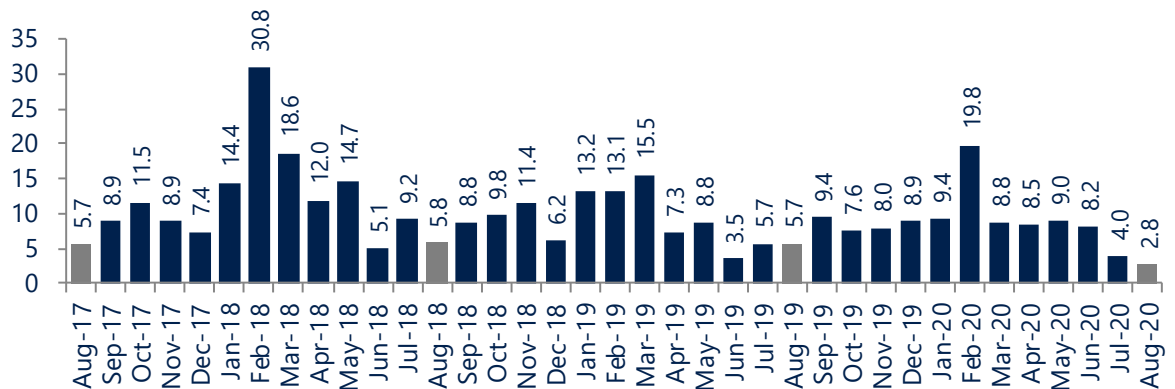


### DAYS ON MARKET Homes \$750,000+
